CONSIDERING THAT, in accordance with the provisions of section 20 of the Règlement sur le domaine hydrique de l'État (RLRQ, chapter R-13, r.1), the consent of the adjacent waterfront property owner, namely the Municipality of Clarendon, must be obtained in order to authorize the lease of the domain;

CONSIDERING THAT the intentions of the Municipality of Clarendon are clear with respect to its refusal to consent to the lease of the domain of the State in front of the property known as lot 5 640 667 of the Cadastre of Quebec, in Clarendon;
